Waiver Acknowledgement & Agreement

I acknowledge and agree to the terms and conditions outlined below in this Community Run Club Attendance Waiver (“the Waiver”) in consideration for being permitted to participate in the activities organised by 30-30 Run Club (“the Club”): **Assumption of Risk:** I understand that participating in the Club’s activities, including but not limited to running, jogging, and any related exercises, carries inherent risks and hazards. I am aware that these activities involve the risk of injury, illness, or even death. I voluntarily assume all such risks and will not hold the Club, its organisers, volunteers, or fellow participants liable for any harm that may occur during my participation.

Health and Fitness: I confirm that I am physically and mentally capable of participating in the Club’s activities. I have consulted with a healthcare professional regarding any medical conditions, injuries, or other health-related concerns that may affect my ability to engage in physical activities. I understand that it is my responsibility to exercise within my own limitations and not exceed them. **Compliance with Instructions:** I agree to comply with all instructions, rules, and regulations provided by the Club’s organisers and volunteers. I understand that failure to do so may result in my removal from the activity or event.

Release and Indemnification: To the fullest extent permitted by law, I release and discharge the Club, its organisers, volunteers, agents, and representatives from any and all claims, demands, causes of action, lawsuits, or liabilities, whether known or unknown, arising out of my participation in the Club’s activities. I also agree to indemnify and hold harmless the Club, its organisers, volunteers, agents, and representatives from any claims made by third parties arising from my actions or omissions during my participation.

Use of Likeness: I grant the Club the right to use, without compensation, any photographs, videos, or other media taken during Club activities, which may include my likeness, for promotional, educational, or other purposes.

Personal Belongings: I acknowledge that I am solely responsible for my personal belongings during Club activities and events. The Club, its organisers, volunteers, agents, and representatives shall not be held liable for any loss, damage, theft, or destruction of personal property.

Emergency Medical Treatment: In the event of an emergency, I authorise the Club’s organisers, volunteers, or other authorised personnel to seek and provide emergency medical treatment on my behalf, including but not limited to administering first aid, calling for medical assistance, and transporting me to a medical facility.

Governing Law: This Waiver shall be governed by and construed in accordance with the laws of Western Australia and Australia. Any legal proceedings arising out of or related to this Waiver shall be subject to the exclusive jurisdiction of the courts in your Country/State.
